Mr. Victor Chu – Chairman of First Eastern Investment Group

Victor Chu is the Chairman and CEO of First Eastern Investment Group. He is also Chairman of First Eastern Investment Bank Limited and FE Securities Limited. Over the last 25 years, Victor Chu has served at various times as Director and Council Member of the Hong Kong Stock Exchange, Member of the Hong Kong Takeovers and Mergers Panel, Advisory Committee Member of the Securities and Futures Commission, and part-time member of Hong Kong Government's Central Policy Unit. Mr. Chu is currently a Foundation Board Member of the World Economic Forum in Geneva and co-chairs the Forum's International Business Council. He is also a Member of the Mayor of London's International Business Advisory Council and a main board director of the Zurich Insurance Group.

Last June, Victor Chu was awarded the 2011 Global Economy Prize (jointly with Harvard Professor Lawrence Summers and former European Central Bank President Jean-Claude Trichet) by the Kiel Institute for the World Economy.

諸立力先生是第一東方投資集團董事長兼首席執行官，並為第一東方投資銀行有限公司和 FE 證券有限公司的董事長。過去的廿五年來，諸立力先生曾出任不同公職，其中包括香港聯合交易所董事和理事會成員、香港收購及合併委員會委員、證券及期貨事務監察委員會諮詢委員會委員、香港政府中央政策組兼職成員。諸先生目前是日內瓦世界經濟論壇的基金委員會常務委員和該論壇國際商業委員會的聯席主席，也是倫敦市長國際企業顧問委員會委員及蘇黎世保險集團的董事局主要成員。

去年六月，諸先生獲基爾世界經濟研究所頒發 2011 年全球經濟獎，與哈佛大學薩默斯教授及歐洲中央銀行前行長特里謝共享這項殊榮。
